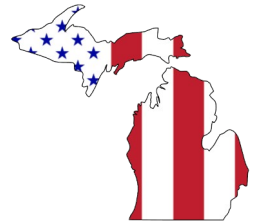

The idea for this proposal originated with Kimberly Watling, who wanted to start a Pay It Forward program, where when it came time for someone to pay fees, they would be notified that the fees have been paid for them by a donation, then they could decide if they would like to do the same. The main drawback to this idea is the matter of Intention. If someone didn't "put their money where their mouth is", so to speak, could someone later accuse The Michigan Assembly of coercing them into correcting their status? This is something that must be avoided. This is when the sliding scale was suggested, much like what is used for the Sign-In American training course.

January 31, 2025: Recording Secretaries agreed some type of payment is necessary. See item #51 in the RS Minutes of Meeting where the amounts for the sliding scale was determined.

February 10, 2025: To bring forward to the Banking Committee for their blessing.
