- Proposal from IT Committee to establish a Link Tree:

- Proposal from Kimberly W to close down Telegram Channels
 - Written proposal on pages 3-4 of this agenda.
- Proposal from Debra-Ann G regarding use of Telegram Supergroup:
 - Now that the Decorum Guidelines are accepted and in place on the Supergroup, consider using the Supergroup channel to freely discuss as a community without the limitations of strictly business.
- Proposal from Debra-Ann G to develop Administrators and/or Peacekeepers on Telegram Channels:
 - The key factor to success if the Decorum Guidelines is determined by the people who have stepped forward to act as Administrators of our assembly channels, both public and private. At this point in our development we need to determine how many, who and what skills are maybe needed.
 - Should there not be the minimum admins as we determine to work comfortably. I, Debra-Ann, propose there be a group of volunteers who regularly use the channel to act as peacekeepers. An informal group who love freedom and love peace, but who know that debate on a topic is needed, it is the name calling and demeaning of a man or woman's or committee or role that is unacceptable. Those who use this medium of communication need to step up to help make this work.
 - Addition by Nicholas K: Administrators will be appointed by Oversight Committee once established. IT & Communications Committeemen will by default hold an Administrator role(s).
- Proposal from Nicholas K regarding GA vote last week:
 - Repeal vote by the General Assembly of the Ombudsman proposal voted on August 27, 2024.
- Proposal from Nicholas K regarding censure of committee chairs:
 - Consideration for Censure of Committee Chairman/woman who have been arbitrarily ending video conferences without a Move-to End, Seconded, and voted by attending Committee Members. This constitutes petty tyranny and power creep. By doing so they're circumventing Checks and Balances. Committee Chairman/woman serve the General Assembly.
- Proposal from Nicholas K regarding establishment of Oversight Committee:
 - Establish Committee
 - Elect Chair, which may not be Ombudsman
 - /Oversight will be removed (needs explanation)

I propose the permanent closure of The Michigan Assembly Telegram Channels – All of them. Meaning NO more Telegram for The Michigan Assembly.

I recommend focusing on pillar building and the service and protection of our people on Michigan. Instead of wasting time and energy provided by this social media platform. I have now witnessed 2 iterations of TMA 3 and 4 being completely and ridiculously consumed by this festering boil on the face of TMA.

In my witness, every TMA problem and consequent responses wasting valuable pillar building efforts is because of Telegram. I am disgusted, appalled and now embarrassed. Trump, Biden, Harris and even our own Whitmer are showing up way better than we are.

It's our duty to serve and protect our people. We must create our own proprietary infrastructure. Period.

There is no other solution. Nothing we are doing or have done thus far since April 27, 2024 when TMA 4 began - has required Telegram. In fact, it has been our biggest problem and distraction. We are negligent in our duty serving the people.

I will not participate. And, if Telegram remains a TMA insistence, please to all, thank you, but please do not "keep me in the loop". I am not interested at all.

-I will also not participate in discussions resulting from problems from Telegram, please don't waste my time at any committee meeting on Telegram issues. They are not the people's issues and therefore, I do not care.

-I will also not participating in offering any contributions to Telegram channels: minute's, links, docs... etc.

-I also do not consent to having it be my responsibility to access public record via TMA Telegram.

Finally, GA has been informed by our State Coordinator, that Telegram was her choice as a quick fix remedy to transition and inform the public from TMA 3 and 4 amidst attempting to stabilize and inform all.

This appreciated and said: Enough.

GA did not vote on or approve this platform... ever, not even to this day. Respectfully to all having worked for hours, discussed for hours - behaviors and rules and procedures... for adults "who should know better" – has engulfed weeks and hours time and energy away from serving and ultimately protecting our people.

Think of this, If every comment and the time it took on Telegram was even used as Outreach time with another man or woman needing rescuing – I bet those personal talks Yes, Talks! would have moved TMA further to standing and seat-ment than absolutely anything and Everything that has transpired on Telegram since April.

We, the ASN's of GA have instead been fighting with each other.

Why?

Seriously, why?

I am done with this. I will not participate in the American Government using Telegram to operate. It is a plan of failure.

As a matter of State National security, we owe it to our people to create the American infra-structure. And, it is closer than we are allowing investigations to pursue.

I recommend a full launch into learning our options and creating a sound proprietary plan for how we secure our proprietary American Government, communications and infra-structure independent from existing captured, censored and monitored infrastructure.

This is the success plan and that which is not expected from us by those attempting to impede our way... Our only successful way. And it is far closer than any TMA GA currently comprehend.

Once we have this base established we stand to succeed. Why?
Because we are a secure Nation State - capable of serving and protecting the good people and assets on Michigan.

Do you really see this – The American Government operating on Telegram?

My linktree option of Facebook was laughed off proposal as “not wanted” – so why, is Telegram - likely another controlled opposition creator like Facebook CIA with the agenda to -by consent - track, sensor and control the platform?

Don’t like us?... then, “No! platform for you!”

Why are we allowing others the control The American Government on Michigan?
May as well just invite Gretchen to join, witness and jump on in! Proud times...

I move to permanently close and retire the TMA Telegram channels and invest in our own actual proprietary infrastructure of, by, and for the people.

1 and 3:

I propose opening discussion considering moving TMA GA open call and business meetings from every Tuesday to the 1st First and 3rd Third Tuesday's of the month.

I believe this would afford more efficient use of time for constructive, forward-moving committee work with a little more breathing room than the current weekly schedule and allow for returns/responses from others on tasks assigned to gather information or implement, continue, complete work on desks, and will offer GA and the public more ripe content in reporting how The American government on Michigan is serving her people.

And, with peaceful Militia preparedness duty, many harvest and prepare for winter... some additional living time is needed at certain times of the year and this would allow for the family and home of our GA to be properly attended to.

2 and 4:

For the 2nd Second and 4th Fourth Tuesday's, I propose a peaceful militia study group from 6-8pm for those who can make it. With so many talented men and women on Michigan and the terrific resources we are to each other - we should consider using this time to check in with each other, share preparedness and study all the great things we are capable of doing when a little help from our friends.

And to the final type of Tuesdays... I believe we can in cycle, have up to 5 – 5th Fifth Tuesday's in a calendar year. One, of which, could fall in December. With many working on end of year tie outs, holidays, travel and natural culturally rich in "family time" occasions – in the event of this, a fifth Tuesday in December - I suggest to allow for family time in lieu of an Assembly meeting – conditional on stable state of the Nation and or the wanting/need to gather.

The additional 5th Fifth Tuesdays, perhaps we consider them Outreach events! - Where we actually aim to gather somewhere (each to be determined, TBD) on our beautiful Michigan or, TBD as the date approaches and according to best need.
