Proposal Language:

Shall The Michigan Assembly Affirm to Uphold Peace and Out-Law War on Michigan Nation State?

Describe how this proposal serves:

This proposal serves and protects the people on Michigan because Peace begins in Sovereignty and choice; with each man and woman of their own Freewill and in their so choosing.

We are a sovereign people in Peace; at Peace ...

In Love, Affirming and Upholding Peace for all living beings with Divine consciousness, loving hearts and keen minds; with Compassion; in Plenty, and in Harmony.

We the sovereign American government on Michigan are not void of delegation of authority, as our subcontractors are; and as such we can Out-Law War on our sacred sovereign land; making it: The Law of the Land; and in move to protect our people and those we love.

Restoring peace. We are ending War. Not just the perception of 'War', but all the warring being constantly, in all forms, perpetrated on us; and for all future or otherwise alternate instances/attempts to war against the people; by any and all things contrary to the Good of men and women = The People, Michigan Nation State, The United States of America and our beautiful Earth realm. All, that we love.

Beyond the absolute [evil: in powers and principalities among us];

The Especially egregious and intentional acts by any and all agents and principals of registered corporations, meaning "Incorporated" entities, aka legal fictions;

Infiltrators – 'foreign and domestic';

Usurping jurisdiction with No Sovereign Delegation of Authority to do so; and

All who claim any authority to regulate, govern, make 'controls of', to: rape, rob and fleece the Rights of American's, living women and men; knowingly or un-knowingly; and

against The Common Law; The Laws of Nature and of Nature's God; and

Against our Constitutions in Treason; and

Who act in impersonation of us; The real American Sovereign Government – The Michigan Assembly non-incorporated on Land and Soil – as called, in as 'Last wo/men standing' to "Assemble!" being brought into Session by The Federation of The United States of America.

The Sovereign Government of, by and for The People on Michigan Nation State; and as referenced both in:

"CONSTITUTION OF MICHIGAN OF 1835;

In convention, begun at the city of Detroit, on the second Monday of May, in the year one thousand eight hundred and thirty five:

Preamble.

We, the PEOPLE of the territory of Michigan, as established by the Act of Congress of the Eleventh day of January, in the year one thousand eight hundred and five, in conformity to the fifth article of the ordinance providing for the government of the

territory of the United States, North West of the River Ohio, believing that the time has arrived when our present political condition ought to cease, and the right of self-government be asserted; and availing ourselves of that provision of the aforesaid ordinance of the congress of the United States of the thirteenth day of July, one thousand seven hundred and eighty-seven, and the acts of congress passed in accordance therewith, which entitle us to admission into the Union, upon a condition which has been fulfilled, do, by our delegates in convention assembled, mutually agree to form ourselves into a free and independent state, by the style and title of "The State of Michigan," and do ordain and establish the following constitution for the government of the same.

ARTICLE I BILL OF RIGHTS

Political power.

First. All political power is inherent in the people.

2. Government is instituted for the protection, security, and benefit of the people; and they have the right at all times to alter or reform the same, and to abolish one form of government and establish another, whenever the public good requires it.";

PREAMBLE

We, the people of the State of Michigan, grateful to Almighty God for the blessings of freedom, and earnestly desiring to secure these blessings undiminished to ourselves and our posterity, do ordain and establish this constitution.

We, the people of the State of Michigan, grateful to Almighty God for the blessings of freedom, and earnestly desiring to secure these blessings undiminished to ourselves and our posterity, do ordain and establish this constitution.

Article I

DECLARATION OF RIGHTS

§ 1 Political power. Sec. 1. All political power is inherent in the people. Government is instituted for their equal benefit, security and protection.

History: Const. 1963, Art. I, § 1, Eff. Jan. 1, 1964

Former Constitution: See Const. 1908, Art. II, § 1.

§ 2 Equal protection; discrimination. Sec. 2. No person shall be denied the equal protection of the laws; nor shall any person be denied the enjoyment of his civil or political rights or be discriminated against in the exercise thereof because of religion, race, color or national origin. The legislature shall implement this section by appropriate legislation.

History: Const. 1963, Art. I, § 2, Eff. Jan. 1, 1964

§ 3 Assembly, consultation, instruction, petition. Sec. 3. The people have the right peaceably to assemble, to consult for the common good, to instruct their representatives and to petition the government for redress of grievances.

History: Const. 1963, Art. I, § 3, Eff. Jan. 1, 1964

Former Constitution: See Const. 1908, Art. II, § 2."

We, the people are owed The Law of Peace. It is Our unalienable right. And We claim it. We command it. Now.

Be it Ever-Clear: This Affirmation to Uphold the Peace and to Out-Law War, does not concede one's rights to defend one's self. We reserve all rights and waive none.

We stand emboldened by The unanimous Declaration of Independence wherein:

"We must, therefore, acquiesce in the Necessity, which denounces our Separation, and hold them, as we hold the rest of Mankind, Enemies in War, in Peace, Friends."

Additionally, We are advised through Justice Anna VonReitz:

Our world and people will not be able to receive 'that which is due' until, there is Peace... on the Land and Soil and in the hearts of all. Be Peace. Be the change you wish to see.

If we, The Michigan Assembly of 2025, advance the "10th day of May 2021 Roll Call Vote by the Citizens of The Michigan Assembly"; to 'Affirm to Up hold', the previous and still largely unknown "Proclamation of Peace" as voted by all 50 State Assemblies and autographed by Head of State James Clinton Blecher; on the 1st day of August, in the year of our Lord 2021; then, we protect the people; and

through Outreach – we inform and we spread the Good News! The People voted: The Republic was kept.

And No More War! Peace, Peace, peace...

and;

This, All while we "Instruct our representatives" in Notice to our current sub-contractors – agents and principals; under Our employee manuals, otherwise named Constitutions;

And, by acting to 'Out-Law War'; the warring must cease.

And, any such acts of war against The People here after will be lawfully met swiftly, and enforceably with the full extent of the Law in Due Process on all liable men, women and entity(s) incorporated; as re-iterated from 1835 is The: "Right of the people.

So, in our Right to peacefully assemble, and in consult for the common good;

We, The People 'stand for', our and 'claim' our, rights, in peace;

And per Maxim of Law "it must be expressed";

Thus, we Declare it is so. We claim Peace on Michigan. No more War. No Trespass.

On our breath of life, through Freewill; please vote peace. Let the will of the people be known and heard throughout the lands.

We Command all Evil to be removed from Michigan and the Earth realm; Never able to return; Now.
