Also discussed survival and the self-reliance end of the Militia, for yourself and your community. Second Amendment discussion about safety during meetings and potential upcoming training. Meetings are on the first and third Tuesdays of each month, same day as the GA business meeting. The next Decorum meeting has not been scheduled; look for that soon (Recording 00:47:53)

#### Vetting, by Rick Worden

UPDATE (3/4/25): It was requested by Debra-Ann Garcia Wagner that the idea of the coordinator or chair of committee refraining from a vote will be reconsidered in the Working Group meeting.
