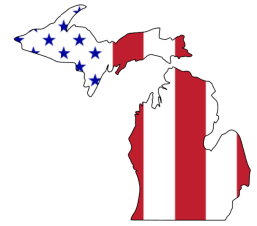

Coordinator Updates, by Amy Hunt

- Summary: Several Q and A with the Federation of States this past week. First group of questions were about the PKTF and its role in the State Assembly, in assembling, standing and the seatment process. An unofficial seal of approval was given to Kimberly Watling as a PKTF Liaison for Michigan at an earlier GA meeting. An invitation was made for a proposal to be presented to the GA to elect her. PKTF is limited to networking, not oversight. Reviewed requirements for becoming Assembly men and women, including what notices/letters are appropriate. Voter cancellation is important for protection. The Declaration of Political Status is appropriate along with the 1779 and two witnesses. Sending letters to the Secretary of State doesn't need to be required to serve in the Assembly but its a good idea to complete anyway. Military severance is required for status correction. Proxy voting question (asking someone else to vote for you if you are unable) can be considered with a handwritten and autographed letter with explicit details and timeliness. 18 March 2025 Tuesday General Assembly Meeting Ombudsman Report

Welcome the members in attendance.

Review the Correspondence with the Chairs of committees and the Moderators of the Working Groups.

The first week of the March the International Ombudsman Think Tank met on Thursday. The presentation involved looking forward and envisioning the role of this meeting going forward. The attendees had the opportunity to explore the question of how an Ombudsman interfaces with their assembly helping to build as a member of the assembly as a man or woman and when their office was active. There were a couple of overarching thoughts. One was that the Ombudsman was only acting as an Ombudsman once a complaint invokes this office. The other thought was that the Ombudsman is always a silent observer.

This Ombudsman has finally answered this question based on how people in The Michigan Assembly responded to an incident that was triggered by her response to an action of a chair in another committee. The results was a change in how the Ombudsman will interface with The Michigan Assembly for the benefit of the Assembly. These ideas were review by both the Coordinator and the Marshal-At-Arms.

These are the changes that will be implemented going forwards”

A formal report will be provided to the Assembly at the General Assembly Meetings, with a report given to the minute taker for the minutes.

The need for Ombudsman committee meeting are not needed at this time. Our process for individual and committees is in place under the Reconciliation Process in the Ombudsman Services for The Michigan Assembly, which will be available on the assembly members website for download. Should you need this document with the forms before the members website is open for use, please email the Ombudsman for a copy. The meetings will be reinstated when there are new members who wish to be trained as an Ombudsman.

The Ombudsman will attend meetings as an Ombudsman to just observe. Any ideas will be submitted to the Chair in writing. Should a point of fact or order need to be addressed a message will be placed in the chat for use as needed in the meeting.

The Ombudsman will not attend all meeting and May visits only for part of meetings.

This new way of interfacing with the assembly necessitate the relinquishment of the role of Freedom Guide.

These changes are to reenforce the reality that the Ombudsman is independent, impartial and confidential. It is a way to, hopefully, build trust that may have been lost by confusing the woman with the role she would play as the Ombudsman.

The next International Ombudsman Think Tank takes place this Thursday, 20th of March at 4:00pm.
