Meeting Minutes

- Amy Hunt opened with prayer.
- Kenneth Fisher (acting MAA) read the Biven's Decision and meeting protocol.

Please note: the Biven's Decision is now presented upon entry into the ZOOM meeting for those joining the meeting after the official start time.

1) Coordinator Update

a) Where we stand now: We are at "square one" – starting everything over – version 4.0. Amy Hunt had a very productive phone call with Lisa Schaffer, Ohio coordinator, who explained their process where the coordinator "conducts and direct" (think band/orchestra) the building of the Assembly. Each ASN – pick an instrument (your talents and gifts you bring to the assembly) and let's start playing the melody from the same sheet of music! That's the frame of mind to focus on.

b) Things to get involved in and learn about:

- PKTF liaison training: It is recommended that each state has 2-3 PKTF liaisons. Amy provided the link for enrolling in the training <https://pktfnews.org/pktf-assembly-liaison-enrollment-form/>

- **Marshal At Arms:** Kenny Fisher waiting to hear from Joe Hayes about training. Troy Brown sending contact info in email.

- **Ombudsman:** Debra Wagner

c) An Apology: Amy Hunt (AKH), state coordinator, readdressed some unilateral decisions that she made the previous week and brought them back to the General Assembly (GA) those decisions she had made to have the GA vote on them. Her apologies were accepted unanimously.

1) Voting: The GA **moved** to vote on whether or not to use Zoom Chat as the recording device for decision making during meetings. AKH entered the “motion” into the chat and attendees voted unanimously to accept this voting procedure. NOTE: If two men/women are on the same screen, please identify by first name who is voting (example: “Mark Yes”)

2) Attendance: Discussed roll call for meeting attendance. Zoom provides a listing of who is in attendance and how long they are in the meeting. Based on anticipating growing the number of attendees, the GA voted on whether to accept this tool for record keeping. “Motion” passed unanimously.

3) Entry interviews: AKH decided simple process without asking the GA but discussion with members confirmed her decision was welcome and appreciated. The entry interview is simple, yet serious in content, and takes less than 15 minutes. Several have joined in the past week.

4) Participating in “unofficial” committees: AKH asked some ASNs to assist with GA history and communications. See pages 3 and 4 below for details.

2) Acceptance of new Assembly Men and Women

a) Addendum to Entry Interview for those introduced last week (Amy, Richard, Troy, Kenny)

1) Two additional questions were added to the entry interview:

- *Do you understand that anything you create, design, purchase, donate money towards, whether physical or intellectual, will immediately become property of the people/People of Michigan and The Michigan Assembly?*

- *Do you further understand that upon request any such asset must be returned to the Michigan State Coordinator who is approved by The Federation of States at that time?*

2) At 8:12pm, these two questions were read to Amy Hunt, Troy Brown, and Kenneth Fisher (Richard Saroni absent due to storm power outage). Those three ASNs replied individually with “Yes, I understand”. Richard Saroni will complete this during a future GA meeting.

b) Introductions of new assembly members: Jan Buzard, Debra Ann Wagner, Mary Kluklowski, Rick Worden, Mark Steinke, Linda Steinke, and Nicholas Kiciak gave brief introductions.

NOTE: All declared assembly members can vote and asterisks (*) were added in front of those names who are now assembly members.

3) Reports and Unofficial Committee Updates

a) Treasury Update: We currently do NOT have a credit union account and ALL previous donations are being returned to those who donated. Discussed CASH APP for donations and possible transactions; still need more info. Suggestion made to utilize Global Family Group (GFG) vendor cards; need more

info. AKH has already donated \$\$ towards a new Zoom account, Calendly app for scheduling, and “MichiganAssembly.org” domain for a new website. Table discussion for now.

b) Recording Secretary Update: Amy Hunt, Troy Brown and Rene McGuigan are trained but because of personal situations, Amy is the only currently available RS. Those interested in becoming an RS need to complete 928 pkg and obtain training (see AKH).

c) Sign-In America, new program: Debts for a new reiteration of the SIA (mortgage, car loans, college loans). The Federation is requesting a state-wide TOTAL from all 50 states, so a claim can be pressed against the defacto for remedy. Mark Steinke mentioned Anna said during her Monday 5/6/24 webinar that those totals need to be in by the end of the month (May).

d) Unofficial Long-Timer / Solid Foundation Committee Recommendations: Fred Beaudet, Linda Johnson, Richard Saroni and Kenny Fisher were asked to provide insight as to “what went wrong in previous versions” and “how can we fix it going forward”. The addition of the two Entry Interview questions (please see above) is a great start! Acknowledging donations, out of courtesy, and remind that all donations become the property of the Assembly, not individual members. Amy requested a complete summary of suggestions from the group for next meeting. Rick Worden suggested committee structure/protocol including writing reports with bullet points, summarize, and bring back to the GA and report on progress. Kim Watling agreed, and also, on an aside, suggested obtaining a Zoom room so we can communicate together; Nicholas Kiciak suggested Telegram since it is already set up to offer that readily.

A brief discussion regarding copyright issues also occurred. **Amy Hunt confirmed that The Michigan Assembly is a recorded trademark of the United States of America unincorporated, meaning the Federation has the only approval.** At this time, she also brought up the fact that the previous assembly is, unfortunately, keeping all hard copies of recorded documents. She does have all documents saved electronically, but that is “in the air jurisdiction” so we need to figure out how to obtain/manage/archive records going forward. Discussion tabled for now.

e) Unofficial Communications Committee update: Richard Saroni and Jan Buzard have scheduled a Zoom meeting for Wednesday May 8, 2024 at 4pm to discuss technology and communications. All Assembly members are invited. <https://us05web.zoom.us/j/81502468426?pwd=s2qKfOtsNVYBIFBUSCxnqRNOk0Nb6.1>

To obtain and maintain the official Michigan Assembly social media presence, Troy Brown recommended obtaining a phone number specific to the Michigan Assembly (via TEXT NOW), so we can make our own Telegram group, with the suggested name “Michigan Assembly Unincorporated”. This will eliminate any individual ownership and operation going forward. Decorum parameters such as picture and real name still to be determined and agreed upon.

At 9:46pm, a vote was taken to approve the “TEXT NOW” phone number owned by the Michigan Assembly and approve the initial expense of \$9.99/month; passed unanimously. An additional vote was taken to approve the use of the TEXT NOW phone number to set up a Telegram account for the Michigan Assembly Unincorporated; passed unanimously.

4) Things to do Next

- a) Establish communications, simple website: See discussion above
- b) Chair for Vetting Committee: this committee actually needs to get set up as soon as possible. 928s and notices must be completed, and the man or woman will be interviewed by the Continental Marshal. American State Citizen eligibility if you take on the role as chair. Details of role can be found in the Assembly Handbook (AKH read the definition).
- c) Design a new logo: For the Assembly and Recording Secretary seals. Have a design contest?
- d) Establish a working group: The GA is not supposed to be a working group, but rather be a meeting where reports from the various committees are brought before members, along with a time to vote on things; not hours of discussion usually. Any assembly member can join the working group (many hands make light work). Goal is to work on communications, records flow, how do we stay in touch with those people who contact the Michigan Assembly to become an ASN, etc. Think on this for next week!

5) Passport WIN

An Assembly member ran the test online to determine whether/how we, as ASNs, come up in the defacto system. If you have completed your passport via Copper Moonshine (suggested to wait a couple months after you have changed your status and sent notices before applying for a passport), go to myeverify.uscis.gov. You will need to set up an account to complete this. Verify with self-check. The ASN testing this out was identified in the system as a “non-citizen national status” and is eligible to work!

Last but not least, Troy Brown asked if any members are interested in forming an interim litigation committee to continue to help men and women with current situations with the defacto. Please contact him directly.
