Vetting committee chair -

- Troy Brown + Rick Worden have accepted nomination.

- Each will have 5 min. to talk, then you can raise your hand to ask them questions for which you will not be cut off (for the amount of time).

- **Rick Worden** - I write things down to consider them.

- I will decide who is appropriate for a "chair" position.
- We'll need enough people who can be on the vetting committee to help in decisions.
- I have some free time, while I attend to my mother's health.

- **Troy Brown** - I have a little bit of the same as Rick.

- This is like family dinner, without being uncomfortable.
- We just need someone to fit in the right position.
- Where would be people's skill's be put in the best place.
- I run a construction business, but my time is more to the assembly.
- I believe in Anna's work and to the PKTF.
- I'm here to serve the people of Michigan.

- The floor is open to ask these guys questions...

Q - Debra-Ann - How will you see discern if people have the strengths / skills for chair positions.

A - Rick - We'll just see if they have qualifications.

Q - Debra-Ann - Troy, how would you balance the vetting job with being an RS ?

Troy - I'm very high strung, and I multi-task. I've always been wearing several hats at once.

Q - Nick - To both... if something else should arise, would you bail this position of vetting chair ?

Troy - I'm fully committed to this assembly.

Rick - I don't know what might happen, I would stay here.

Q - Mary - If Paul Peterson were to join this assembly ?

Troy - We would not look over it, and deal with it if it were to happen.

Rick - The marshals would do vetting, and it was the assembly that decided it was wrong direction.

Q - James Garner - To both, how would you make it so that with new people coming in, how would they feel comfortable ?

Rick - I saw how people were passing you around online. The vetting role may not get into that role, but only those already in the assembly, and may keep it private.

Troy - I agree, this position doesn't have more than to be about vetting. I always greet everyone from Telegram.

Amy - For clarity, we don't do vetting with the first interview to enter the assembly, but only for those who are to have a role in the assembly.

Q - Linda Johnson - How many in each chaired committee. Are there other positions you are interested in. Would you step down in honor if you have a problem.

Rick - No problem with that.

Troy - As well, I'd step down.

Amy - The coordinator, Treasurer, and the vetting chair... ideally 5, always an odd number.

Q - Linda Johnson - Are there other positions you're better suited for ?

Troy - I enjoy being an RS to meet new people, and I want to do the Litigation.

Rick - Other interests is project management. I have a big view of the militia because of my b.g. in safety.

Q - Kimberly W. - What does the vetting process look for you Q

Troy - If you are eligible for the position you're looking to do. The Continental Marshals will help that.

Rick - I won't know till I'm vetted by the Continental Marshals.

Q - Mary - Others counties are doing other things... do you have connections with other groups that are doing similar activities ?

Rick - No, this is the only assembly I'm doing.

Troy - Same here... I looked at other patriot groups, but Anna is where my loyalty is at.

Q - Linda J. - Vetting chair has to be vetted first ?

Amy - It is a state citizen position. I was not vetted to be a coordinator. We only vet the one who is elected.

Q - Nick - This is a qualifying Q.... which of you would be able to blah, blah, blah (talked too fast) ?

Troy - Yep.

Rick - Gotta get stuff on paper.

Q - Amy - How would you separate vetting from personality ?

Rick - I've been talking about personality a lot, and it helps to discern a person. All the training I've had in the last year will help... what we can prove and document.

Troy - Vetting is about facts rather than opinion. We'll have lots of people coming thru, and may not be our cup of tea, but this is a rescue mission... to see if they're qualified.

Q - Linda J. - There's certain protocol's to be a vetting chair... if there's a change, could you change if the committee was dishonorable ?

Troy - The Continental Marshals are the highest honorable position. I would weed it all out with the assembly.

Rick - If I see anything dishonorable, I would speak up. Anything would be approved by the assembly.

Q - Mary - Do you have any experience with 12 steps or positions ?

Rick - I've never been involved in that.

Troy - I've had friends who have gone thru those programs.

Amy - Any more questions ?.... I now close the question portion.

- We will type the name in the chat next week.

Kimberly - Are RS's vetted in position ?

Amy - We were vetted by the Continental Marshals, but that has changed.

- The RS in the past has not gone thru any vetting, but I think we should now.

- They should conform that they'll perform in honor.

- We can't vet any until we have the vetting committee first.

Amy - Every position is a pro-tem ... but we're not ready for the big time yet.

Treasurer pro-tem (temporary) -

Amy - You can nominate anyone in the assembly... or yourself.

Debra-Ann - I nominate Mark Steinke.

Rene McG - I 2nd it.

Mark Steinke - I accept.

Amy - Anyone can have more thorough Q.'s next week.

Amy - **Conflict resolution...** last week Thursday at 6pm, May 23, 2024.... and Debra-Ann was the Ombudsman. **Anyone is welcomed to attend...** I'll make sure a link goes out... and here's one in the chat...
