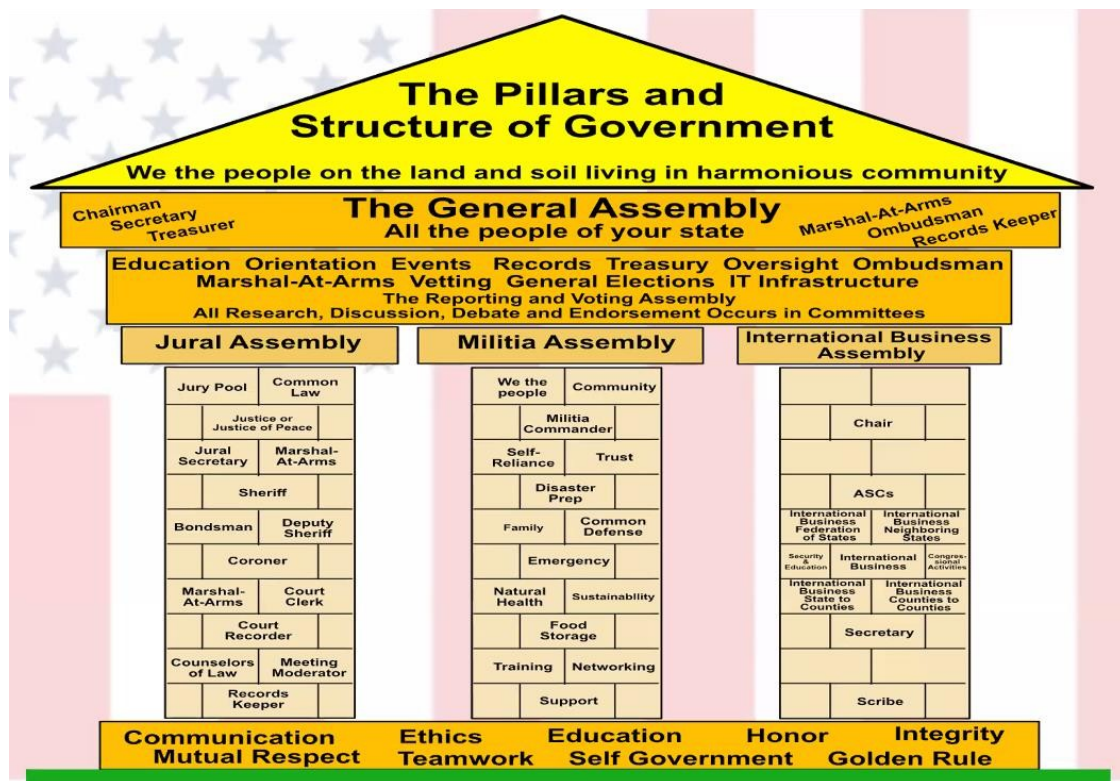
Coordinator Meetings: Attending Thursday training. No country-wide Sunday meeting this week.

Will need laser printer to use for official Records. Learned more about Ombudsman service. Need to meet with Debra. Next week Joe Hayse will be attending our meeting.

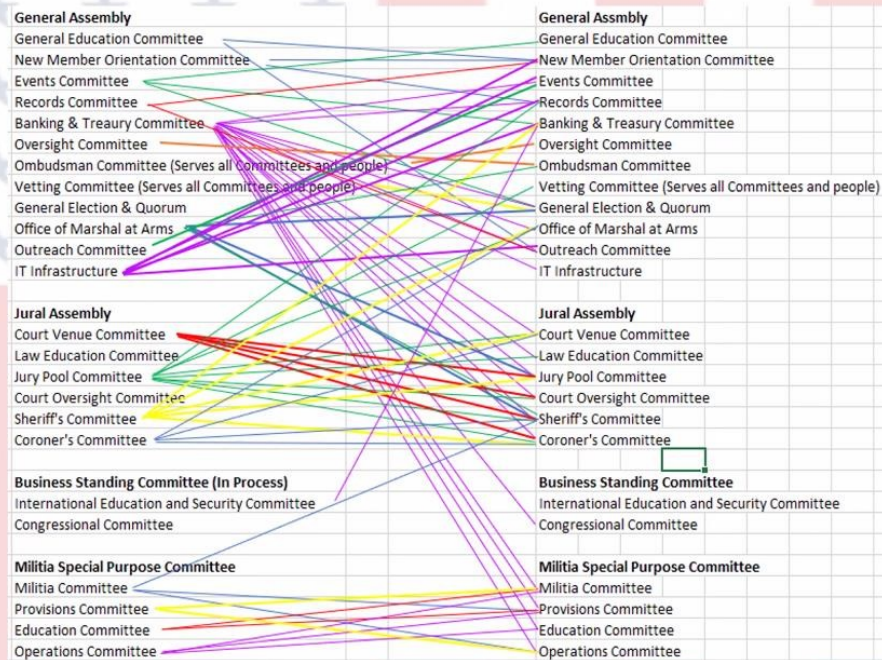

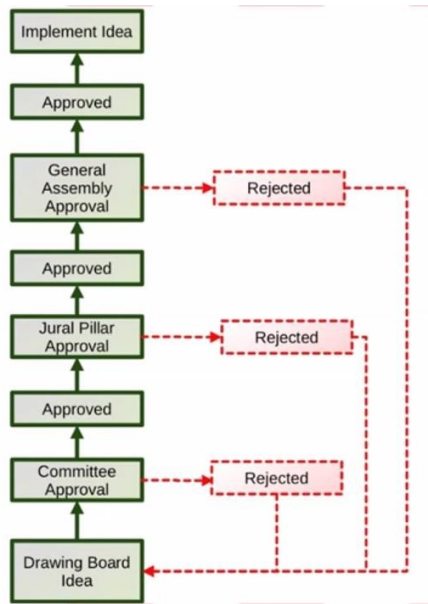
