Ombudsman/Oversight, by Debra GW

- Meeting Thursday July 11<sup>th</sup> at 6pm to discuss decorum on social media and during meetings. All voices needed and appreciated.

Vetting, by Rick W

- Still waiting on vetting from Continental Marshalls. Rick's background check has been submitted. Vetting committee meeting this week to discuss trying to move forward while waiting.

Information Technology & Communications, by Jan B

- Technology Stats document shared. Current website having some technical difficulties.

Litigation, by Troy B

- Took week off for holiday. Adding "raise hand" to meeting decorum. Working on educational notice for law enforcement. Anticipating clarification on new state notice during the "All States Litigation" meeting Thursday July 11<sup>th</sup> with Kristi and Doug.

The Working Group, by Rick W

- Did not meet last week so no report; meeting Wednesday July 10, 2024.

### **Special Guest – Joseph Hayse, PKTF Director**

- The presentation starts at the 34min mark for details. PKTF is currently only providing advocacy and peace while the assemblies work on perfecting self-governing. Charter is similar to first generation of the UN (which has evolved 5x). Accountability comes in the future. Recommends studying the UN Charter and Government Accountability Office (GAO) along with the similarities between the State Militia and National Guard. Shared PKTF website links (see chat). Outreach is the pinnacle of PKTF's existence. Evaluation, education and coordination between State/county peacekeeping entities and advocacy services across the aisle of what the State of State and their law enforcement offers. Think "conduit" and "interface" for understanding of the PKTF role between the Assemblies and Defacto. There are three (3) types of PKTF liaisons (outreach, oversight, ombudsman). Per Joe, at this time, PKTF does NOT provide training for State-elected MAA (Jural Assembly) or State-elected (or appointed) Ombudsmen (GA official). Kimberly W's outreach report has the links for the first PKTF orientation. She shared the role of the PKTF liaison is a neutral role between Defacto sheriffs, introducing them to "us" – we are active and in session!
- Discussion about the Civil Peace Time flag, dimensions and flag protocol – part of the Oversight Committee responsibilities per Joe (1 hr 20 min mark).
- PKTF liaisons can be on any committee as a support member, but not as committee chair.

### **Coordinator Updates**

Coordinator Meetings: No meeting last Thursday or Sunday due to the holiday weekend.

Other Updates:

- Credential card updates on hold. Autograph, address and expiration date requested by Defacto to recognize. New design in process. Eventually produce our own on Michigan.
- Amy's email addresses are numerous and many emails have been ending up in spam, junk, etc. Once she determines new ones, she will communicate.
- Donation opportunity: Gift registry on Amazon for State Records Committee and Recording Secretary needs. If anyone has equipment donations to offer, that is also an option (not too old and needs to be laser printer). Gift card funding discussed as an option. Will post in Treasury SuperGroup and email all assemblymen once opportunity is finalized.
  - **MOVE** to approve this idea made by Rick W, second by Linda J. Approved by verbal vote.
- Mary K and Amy H will be auditing state records returned by the previous assembly for accuracy. Laser printer request on Amazon plus toner/paper will assist with this effort.

### **In Process Action Updates**

- Michigan State Coordinator Contingency Plan – Amy H presented proposal via document. All meetings can start via three (3) ZOOM links/accounts (Amy H, Richard S, Troy B). If Amy H can't moderate the GA, Rick W will step in. If Amy H is no longer coordinator, no matter the reason, the MAA immediately assumes Coordinator role temporarily, to avoid dissolving, until a volunteer is identified. Contingency plan for the Michigan Assembly will be written up generically for future. Document will return to the GA for approval once edited and finalized.

## New Agenda Opportunities

- Review paragraph 10 of Anna Von Reitz's article #4883, The Office of Marshal at Arms, and consider potential application (Rick W): Rick requested it be removed from the agenda as it was no longer relevant. Others disagreed. **MOVE** to not discuss at this time; it is for future use made by Debra GW, second by Troy B. Approved by verbal vote. (time in recording: 2:22:50)
- Amy Hunt or Education Committee Chair give a 5-15 minute General Assembly presentation on the DunningKruger Effect (Nicholas K): Nicholas K was not present at this time in the meeting. Amy H asked if anyone wants to talk about it. Rick W suggested we not talk about it since Nicholas K is not present. **MOVE** to table this until next week made by Troy B, second by Fred B. (time in recording 2:26:30). Amy H placed it in the chat for a vote: **Should we table the discussion to have Amy Hunt or Education Committee Chair give a 5-15 minute General Assembly presentation on the Dunning-Kruger Effect? Yes or No? (time 2:37:16) YES 15 NO 4.**
- General Assembly Checks and Balances against potential or real abuse by Committees, Subcommittees and Workgroups (Nicholas K): Kimberly W recommended tabling this item until next week when Nicholas K has the opportunity to speak (time 2:40:12). **MOVE** to table until next week made by Kimberly W, second by Rick W. Approved by verbal vote.
- Review Anna Von Reitz's article #3374, Warning Signs That You Have District Infiltrators (Debra GW): This will be covered during the Ombudsman meeting on Thursday, July 11th. **MOVE** to send to the Ombudsman Committee and return to the GA with a proposal made by Debra GW, second by Fred B. Approved by verbal vote. (time 2:39:32).
- Communications: Telegram and who needs emails or texts. (Debra GW): **MOVE** to send this issue to IT/Communications meeting on Friday July 12 made by DebraAnn, second by Kimberly W (time 3:04:25)
- Participating in a Grand Rapids farmer's market for Outreach (Mary K): Neighbors starting up Farmer's Market in her neighborhood. Saturday July 13<sup>th</sup> from 9am to 1pm. Usually this would be brought up in the Outreach Committee. Due to time constraints, please reach out to Mary Klukowski directly if you'd like to assist with that event.
- Recording Fees "In Duress" (Troy B): Started discussion during Recording Secretary report earlier in the meeting but stopped when Joe Hayse arrived. Amy H proposes we don't vote on this right away and hands were up, but GA meetings are not for discussion. Mark S and Amy H request a more concrete definition of "in duress" so it doesn't get abused. Does publishing on the LRO help with these situations? **MOVE** to take discussion to Litigation Committee for definitions and bring back to the GA made by Troy B, second by Linda J. Approved by verbal vote. (time 3:00:15)
- Discontinue using the open mouth emoji during committee/workgroup meetings and GA meetings (Jan B): It was never voted on at a GA meeting. Distraction to meeting flow and has potential for abuse. **MOVE** to discuss during the Ombudsman meeting on Thursday July 10th made by DebraAnn, second by Linda J and Troy B. Approved by verbal vote. (time 3:03:33)
