The defacto is not consistently accepting current credential cards as ID, thus the push for a new design. Amy P asked about July 13<sup>th</sup> GFG email about each state getting our own CC equipment; Amy H has no information on that.
- 3) General reminder: As general meeting chair, Amy H is in control of moves and discussions, so please respect the cadence of the meeting. Use "raise hand" function to make a move and second the move.
- 4) Affirmation: Aaron Stoddart-Cordova has accepted the role of Recording Secretary for a term of one year. Witnesses are Rene McGuigan and Mary Klukowski. Read and autographed with thumbprint.
- 5) MAA position: Kenny F learned during the bridge call that there is no MAA "Committee" but rather it's an office. Amy H and Kenny F will get together soon to continue working on the Coordinator Contingency Plan. Once counties are stood up, MAA on counties will form committees, along with the State MAA.
- 6) AVR Webinar clip on Community Government: Good reminder to shake hands; be kind; put your best foot forward; be positive; service-focused; and does it help set up our pillars? Just be nice to one another! For the full clip, it started about 50 minutes into the meeting. No more "curluffels", please!!! (AVR)

- Ombudsman Committee seeks approval of Decorum Guidelines for The Michigan Assembly Public Telegram channel. The following is the actual language being voted on:

*Welcome Men and Women to The Michigan Assembly!*

*Welcome to our home.*

*We observe we are governed by the laws of Nature and Nature's God and therefore we live in honor and respect of one another. We are here offering friendship, support and love to you as you seek freedom.*

*As you engage with us here, we encourage you to treat others as you wish to be treated. Be kind. Do no harm. Please observe what we consider Decorum violations:*

- Advertising
- Vulgarity
- Name-calling
- Threats
- Personal Attacks
- Accusations
- Trolling

*The above will not be tolerated and will be treated in the appropriate manner.*

*These violations cause harm. As sovereigns, we recognize that our sovereignty ends where another's begins. As such, violations may include disciplinary actions, up to and including, but not limited to, deletion of the comment, time outs, and/or your removal from this channel.*

*Again, we welcome you and look forward to getting to know like-minded people as we work toward a better future*

**MOVE** made by Debra GW, seconded by Rene M. Verbiage was read out loud. "Shall we adopt the decorum guidelines for the Michigan Assembly Public Telegram Channel as proposed by the Ombudsman Committee" posted in the chat at 8:07pm; vote ended at 8:08pm.

YES = 14; NO = zero; Abstain = zero. Guidelines passed unanimously. They will be posted on the Public Telegram channel.

- Working Group seeks approval to adopt the following language to be included in the eventual General Assembly Handbook/Decorum/Rules of Order: "If a man, woman, or committee who submitted an agenda item is not at the meeting, the item will be taken off the agenda and can be resubmitted by the man, woman, or committee at a future date". A brief discussion about the process of adding agenda items followed. Amy H reminded everyone: 1) add to the Agenda items TG Supergroup by midnight on Saturday; 2) email Amy H ([mymichiganassembly@gmail.com](mailto:mymichiganassembly@gmail.com)); or 3) ask more questions to assign it to a committee agenda (where there is debate and discussion). **MOVE** made by Rick W; seconded by Debra GW. "Shall we adopt this language as part of our meeting rules of order/decorum" posted in the chat at 8:21pm; vote ended at 8:22pm. YES = 13; NO = zero; Abstain = 3. Passed.
- Working Group seeks discussion on whether or not to record training presentations, with vote next week. The goal is to develop educational material we can reuse. The purpose is NOT to record committee meetings. The proposal is to record training and presentations during the public portion of the GA meetings and make available for training later and add to the website.
