Ombudsman/Oversight, by Debra GW

- Summary: Committee meetings on Thursdays at 6:00pm. Discussions have been centered on decorum for meetings and Telegram. Proposals for Decorum in the GA Supergroups on Telegram and the “Open Mouth” emoji during meetings will be presented later in the meeting (see attached). Will also be looking at decorum for the GA meetings in the future as well as debating parameters, because we will be debating!

#### Vetting, by Rick W

- Summary: Voting on a proposal later in the meeting. Continue wordsmithing documents for Michigan from the vetting section of the Ohio documents.

#### Information Technology & Communications, by Jan B

- Summary: Discussed the “assembly member only” part of the website, including links for minutes and meeting recordings so we eventually won’t be emailing those to members or posting on Telegram. Considering the administrative process to obtain the “michiganassembly.net” domain rather than pay \$700. Website development continues, including site navigation, color, and document generator.

#### Litigation, by Troy B

- Summary: Shelving the “defining duress” discussion for now. Coming up with a proposal for the GA to elect public notaries. Putting together a procedural manual describing the position and responsibilities. Committee will bring this to the GA when completed. Welcome to attend meetings Fridays at 7pm.

#### The Working Group, by Rick W

- Summary: Discussed business purposes of the Telegram Supergroup channels and will review proposal later in meeting. Worked on the Marshal At Arms role description; shared with GA members over the weekend. Continue to “Michiganize” documents from the Ohio Assembly. Roles and assembly guidelines are complete. The Jural Assembly and Coroner handbooks complete (#11 & #12) but need more content. Rick W will continue to convert remaining documents until done.

- Summary: Session Two training continues this Saturday at 7:30pm. Link to the Zoom meeting is on Telegram and put to chat. Marshal at Arms meeting Friday at 6pm MTN time (8pm Eastern) which is open to all Nationals this week.

### **Coordinator Updates**

Coordinator Meetings: Sunday’s coordinator meeting with Teri Sahm focused on the circulating emails from the “National Assembly” (better known as the Michigan General Jural Assembly, who are NOT status corrected and remain as U.S. Citizens so they have no standing). AVR attended and addressed this subject. More details can be heard in the recording starting at the 18:00 minute mark. Covers James Clinton Belchar’s personal situation with his daughter many years ago and Anna’s blood oath that she took (and has written about several times in her articles). Worth the time to listen to learn and understand the real story so we can respond lovingly and confidently to those misinformed.

### **In Process Action Updates**

- Litigation Committee seeks approval of allowing people who are “under duress” to have notices published to the LRO at no charge. The Committee has requested this to be removed from the agenda for now as they continue their discussions within the committee (Aaron SC and Troy B)

- **Banking Signatories**: Kenneth (Kenny) Fisher and Charles (Charlie) Raffoul have volunteered to be signatories. Mark S reviewed the role of banking signatories and his support for Charlie as a signatory from a phone conversation with him, along with Kenny. **MOVE** to vote for the banking signatories made by Rick W, seconded by Aaron SC (~7:25pm).
  - Shall we accept Kenneth Fisher as a signatory on The Michigan Assembly's bank and/or Credit Union account? Yes, No or Abstain. Voting via Chat: YES = 17; NO = 0; Abstain = 0. Passed.
  - **MOVE** to accept Charles Raffoul as a banking signatory made by Rick W, seconded by Aaron SC.
  - Shall we accept Charles Raffoul as a signatory on The Michigan Assembly's bank and/or Credit Union account? Yes, No or Abstain. Voting via Chat: YES = 17; NO = 0; Abstain = 0. Passed.

Aaron SC reminded assemblymen to provide an “asterisk \* “ in front of your Zoom name so its clear that assemblymen are voting. Mark S congratulated and thanked both men for volunteering, and promised a banking committee meeting scheduled soon, once he touches base with Kenny and Charlie.

- **Vetting Committee**: Requests the following regarding the use of background checks (Rick W)
  - Authority to use ClearChecks to do background checks
  - Authority to use background checks according to the Prudent Man Standard to determine if a member has past criminal history that might affect job performance
  - Authority to consider doing a background check for any role requiring an autographed Affirmation
  - The Assembly to cover costs of doing background checks.

The above language will be voted on as a package.

*Proposed Decorum Guidelines for the Telegram Super Group, presented to the The Michigan General Assembly at the General Assembly Meeting Tuesday 13 August 2024. Questions or comments will be entertained at the Decorum/Ombuds meeting on Thursday 15 August 2024. A request for acceptance at the GA meeting Tuesday 20 August 2024.*

The Decorum/Ombuds Committee wish to propose the following guidelines

### **Welcome Men and Women of The Michigan Assembly!**

We are governed by the laws of Nature and Nature's God and therefore we live in honor and respect of one another. We work together in friendship, support and love as we build our four pillars of freedom to protect the men and women on Michigan.

Please treat others as you wish to be treated. Be kind. Do no harm. Please avoid what we consider Decorum violations:

- Advertising
- Vulgarity
- Name-calling
- Threats
- Accusations
- Personal Attacks
- Outburst of Rage
- Nonsensical Drama
- Any items as listed in Anna Von Reitz's Articles #3374 or #3816

These violations cause harm. As sovereigns, we recognize that our sovereignty ends where another's begins. As such, violations may include disciplinary actions, up to and including, but not limited to, deletion of the comment, time outs — restricting your ability to post to the channel, and/or your removal from this Super Group Telegram Channel.

### **The process for enforcement includes:**

1. Anyone in the assembly may call out decorum violations, citing the offense.
2. Anyone in the assembly who is not a part of the questionable exchange, may second the call for enforcement.
3. After a second is made to the call, the man or woman who called out the violation will post a message, addressed to an admin (@admin), for enforcement of decorum guidelines.
4. Admin will private message the man or woman who violated decorum explaining the violation(s) and the penalty to be enforced.
5. Admin reports to the Super Group Channel the action taken.
6. Admin keeps records of offense in a separate Telegram group for the admins only.
7. Enforcement will follow a \*graduated penalty structure.

8. The man or woman who has been notified of the breach in decorum may seek additional comprehension, by reviewing the articles noted above in the decorum guidelines and the video, by Anna Von Reitz, posted here: <https://rumble.com/v5agagk-clip-of-webinar.html> , regarding decorum in our assemblies. Should the man or woman need more discussion regarding this enforcement the Ombudsman Committee may be a resource.

**\*Graduated Penalty Structure:**

The Admin has the latitude of using his/her discretion when enforcing the penalties. If the conversation with the man or woman clearly shows they comprehend his/her error completely and it is clear they are genuinely sorry, they may be eligible for just a warning.

o Graduated Structure:

1st offense: 24 hours no posting privileges

2nd offense: 3 days no posting privileges

3rd offense : 1 week no posting privileges

4th offense : removal from the group for 1 week, after which no posting privileges for 1 month

5th offense and future offenses: 1 month removal from the group, after which no posting privileges for 3 months

o Guideline for clearing offense records: 90 days from the last recorded offense

o These guidelines will be posted to the TMA Telegram Super Groups and Admin Telegram Group

The raise-hand emoji creates a cue, but there are times the technology drops and in these cases we must be patient. In addition, we will cease using the open-mouth emoji for immediate recognition. If a comment will answer a question and save precious time, please say "May I." In all cases the moderator retains the right to accept or reject the request.
