Sign-In America, by Amy H

- Summary: Looking to pass on the responsibility of Sign-In America (SIA) Coordinator. Amy H described the role: Michigan Assembly SIA email; field questions from the SIA website. Involves debt relief so need knowledge about the Global Family Group (GFG). Once Federation funding comes to the Michigan Assembly, disperse funds to those waiting from the two programs (2021 and 2024). Must be a declared member of the Michigan Assembly. Outreach/Freedom Guides, by Kimberly W

- Summary: Continue work on four different orientations. Freedom Guides continue to be very busy; we need more! THANK YOU to Amy H, Jan B and the IT Committee with the document generator work for the website! The National Outreach Think Tank has some BIG things coming soon, including new platforms and infrastructures to communicate who we are and how to come home to the land and soil. Next country wide meeting on September 11th. Family reunion out east in November organized by Michelle Ford; reminder if you want to get cheap flights. Donations to either Anna/Federation or the Michigan Assembly are always welcome; QR code in the report that was shared in chat and on TG.

Ombudsman/Oversight, by Debra GW

- Summary: Debra Ann attended the Continental Marshals meeting on Friday August 16th and obtained answers to the many questions about the ombudsman role. Bringing those to the Working Group on Wednesday at 4pm. Researching various ways of running meetings and everyone having a voice.

Vetting, by Rick W

- Summary: Discussed logistics of establishing the Clear Check account for background checks for the Assembly, including how to pay for it. Coordinator will use CashApp debit card until the Treasury Committee establishes a plan for that. Language approved by the GA last week incorporated into the work flow documents.

Information Technology & Communications, by Jan B

- Summary: At the meeting last Friday, Amy H demonstrated the document generator on the website and Jan B shared a form for the 928s. Discussed a page on the website for “the most targeted assembly” because of “michiganassembly.net”. Jan B researching membership plug-ins. Shared the new assembly website <https://mymichiganassembly.land> – OUTSTANDING and available to SHARE! Amy H demonstrated the document generator for assembly members. Please send content and photos to Jan B as she and Kimberly W continue to fine tune the color palette and links.

Litigation, by Troy B

- Summary: The open educational litigation group met last Friday evening, with Troy B following up with two separate meetings with Kristi and Doug (National Litigation) about a notice being worked on; meeting again Thursday August 22nd. Still need to establish a Michigan Assembly Litigation Committee meeting date and time.

The Working Group, by Rick W

- Summary: The “business purposes language” proposal for the Supergroup GA and committee channels to be voted on later in the meeting, but the **amended** proposed Decorum Guidelines for TG Assemblymen Only Supergroup channels may change direction of the proposal and will be discussed later in the meeting. PDFs of the Michigan work flow documents are on TG Working Group channel; could be moving to the website soon! **PLEASE BE AWARE:** any “private messages” in the GA zoom meeting chat are part of the meeting minutes and available to the public view. In order to pursue the admin process for website domains being “held for ransom”, a Litigation Committee dedicated to assembly business needs to be established, as noted above under “Litigation”.

PKTF Liaison, by Kimberly W

- Summary: Lots of meetings with recordings coming; report placed in chat and on TG. Next PKTF meeting August 31st at 7:30pm. A **six phase** process for rolling out information is underway; **Phase 3** specifically involves PKTF involvement. PKTF is providing an “umbrella” to support the National Outreach efforts including Louise Anthony’s post card roll-out and county tours over the next months and year. Listen to previous meeting recordings for details. New infrastructure platform developing including communications (Bobby on Nevada). Exciting times!

Coordinator Updates

Coordinator Meetings: Amy H did not attend the Sunday evening coordinator meeting so no update.

Other Updates:

- 1) Amazon gift registry: Still a few items needed for Aaron SC as Recording Secretary; list placed in chat if you would like to donate to the assembly work in this way.
- 2) CHAT during GA meetings: Direct “private” messages to others in the chat are part of the meeting minutes (as chat transcript) which are on the public record. Please self govern and find alternate methods to chat with each other if you don’t want your private messages viewed by the public. **Please refrain from sending private messages to the coordinator during the meeting as its difficult to monitor those while moderating the meeting. Thank you!**
- 3) Sign-In America: Looking for someone to take this over as coordinator. Please contact Amy H if interested.
- 4) Assembly Secretary Pro-tem: Linda Steinke has volunteered temporarily to take meeting minutes and prepare them for the assembly. The How to Build an Assembly Handbook describes the role as also putting

together meeting agendas. This role will most likely grow as the Assembly grows, providing assistance to the coordinator short-term and most likely the Assembly Chair long-term. It is an ASC position and elected.

In Process Action Updates

- Banking Signatories: Kenneth (Kenny) Fisher and Charles (Charlie) Raffoul were elected last week. Both read their Affirmations, autographed, sealed with their thumb print and showed their documents. Kenny's is at the 50min mark of the recording (~7:50pm meeting time) and Charlie's is at the 52min mark. Kenny's witnesses are Richard Saroni and Linda Johnson. Charlie's witnesses are Rene McGuigan and Richard Saroni. Thank you to both men for your service in this role!
- Electing Marshal At Arms Pro-Tem: Kenneth (Kenny) Fisher introduced himself with a statement and then took Q/A from assembly men and women (56min mark). Kimberly W did a short introduction as the one who nominated Kenny for the position. Please listen to the recording for the complete interview. **Next week** is the election (Tuesday August 27th). "*Shall we elect Kenny Fisher as our Marshal At Arms Pro-tem or elect someone else at a later date*". Since counting the votes is a MAA role, Kenny has recused himself for his own election, so Mark Steinke has agreed to count the votes.
- Ombudsman Decorum Guidelines: The **amended** guidelines (attached) were presented with two items clarified: 1) Recourse for the man or woman who is disciplined is the Ombudsman Committee. 2) Clarification that enforcement affects participation in ALL sub-groups on the Assembly Telegram Supergroup Channel. This second point would be unfair as it would cut-off all communications within the assembly community for the man or woman. The Working Group proposal will include removing the "Feel Good" channel, keeping the Supergroup Channel for posting business items and not discussion. Another Supergroup Channel for all ASNs would be set up providing a place to converse with other ASNs; assembly membership not required. We will vote on this next week.
- VOTE on Ombudsman proposal from last week – "Open Mouth Emoji": Debra-Ann read the proposal (attached). **MOVE** to accept the proposal made by Richard S, seconded by Elsa CP.
→ "*Shall we accept the proposal by the Ombudsman Committee which will discontinue use of the Open Mouth Emoji during General Assembly meetings? Yes, No or Abstain*" placed in the chat ~8:21pm (1:19:00 in recording): YES = 14; NO = 1; Abstain = 0. Passed.
- VOTE on language the Working Group proposed last week: To be added to the Telegram Assemblymen Only Supergroup channels. But after the amended proposal of the Decorum guidelines above to mute the "Fun Times" channel and reroute it to another TG channel, is it wise to continue with the vote or move back to committee? Robert's Rules of order coming up under New Items which may impact this discussion.

"These are the specific business purposes of the Supergroup GA and committee channels:

- Agendas
- Meeting minutes
- Requesting agenda items
- If there are other questions or opinions and the person is not able to go to the committee meeting, then they should go privately to the committee chair. Please do not post the question or comments in the open channel.
- The 'Fun Times and Good Vibes' Channel in the Supergroup is for socializing and bringing up news items."

MOVE to have this go back to the Working Group for further discussion made by Nicholas K, seconded by Kimberly W. Verbal vote **YES** or **NO** – **PASSED** – returned to Working Group

New Agenda Opportunities

- Robert's Rules of Order: From the agenda, the Ombudsman Committee proposes the use of Robert's Rules of Order for our General Assembly meetings substituting various words to meet our purposes eliminating what we do not need but relying on the structure for effective and orderly meetings. Amy H asked Debra-Ann for a suggestion of which committee it needs to go to. Debra-Ann suggests the Ombudsman Committee. Rick W asked about a video shown during the Ombudsman group meeting. Nicholas K suggested the video link be shared in the minutes, so assembly men and women can watch it before next week.

15 August 24 Decorum Proposal Amendment

Proposed Decorum Guidelines for the Telegram Super Group, presented to the The Michigan General Assembly at the General Assembly Meeting Tuesday 13 August 2024. Questions or comments will be entertained at the Decorum/Ombuds meeting on Thursday 15 August 2024. A request for acceptance at the GA meeting Tuesday 20 August 2024.

Amendments discussed 15 August 2024 Decorum/Ombuds committee meeting:

*1.) Recourse for the man or woman disciplined is the Ombuds committee.
2.) Clarification that enforcement affects participation in all sub-groups on the Assembly Telegram Supergroup Channel. [Working Group proposal will include a work around to keep the member in community with the creation of an ASN Supergroup for non-assembly business and all ASNs with similar decorum guidelines.]*

The Decorum/Ombuds Committee wish to propose the following guidelines

Welcome Men and Women of The Michigan Assembly!

We are governed by the laws of Nature and Nature's God and therefore we live in honor and respect of one another. We work together in friendship, support and love as we build our four pillars of freedom to protect the men and women on Michigan.

Please treat others as you wish to be treated. Be kind. Do no harm. Please avoid what we consider Decorum violations:

- Advertising
- Vulgarity
- Name-calling
- Threats
- Accusations
- Personal Attacks
- Outburst of Rage
- Nonsensical Drama
- Any items as listed in Anna Von Reitz's Articles #3374 or #3816

These violations cause harm. As sovereigns, we recognize that our sovereignty ends where another's begins. As such, violations may include disciplinary actions, up to and including, but not limited to, deletion of the comment, time outs — restricting your ability to post to the channel, and/or your removal from this Super Group Telegram Channel.

The process for enforcement includes:

1. Anyone in the assembly may call out decorum violations, citing the offense.
2. Anyone in the assembly who is not a part of the questionable exchange, may second the call for enforcement.

3. After a second is made to the call, the man or woman who called out the violation will post a message, addressed to an admin (@admin), for enforcement of decorum guidelines.
4. Admin will private message the man or woman who violated decorum explaining the violation(s) and the penalty to be enforced.
5. Admin reports to the Super Group Channel the action taken.
6. Admin keeps records of offense in a separate Telegram group for the admins only.
7. Enforcement will follow a *graduated penalty structure. Enforcement affects participations in all sub-groups.
8. The man or woman who has been notified of the breach in decorum may seek additional comprehension, by reviewing the articles noted above in the decorum guidelines and the video, by Anna Von Reitz, posted here: <https://rumble.com/v5agagk-clip-of-webinar.html> , regarding decorum in our assemblies. Should the man or woman need more discussion regarding this enforcement the Ombudsman Committee is a resource.

***Graduated Penalty Structure:**

The Admin has the latitude of using his/her discretion when enforcing the penalties. If the conversation with the man or woman clearly shows they comprehend his/her error completely and it is clear they are genuinely sorry, they may be eligible for just a warning.

- o Graduated Structure applies to all subgroups in the channel:

1st offense: 24 hours no posting privileges

2nd offense: 3 days no posting privileges

3rd offense : 1 week no posting privileges

4th offense : removal from the group for 1 week, after which no posting privileges for 1 month

5th offense and future offenses: 1 month removal from the group, after which no posting privileges for 3 months

- o Guideline for clearing offense records: 90 days from the last recorded offense

- o These guidelines will be posted to the TMA Telegram Super Groups and Admin Telegram Group

Proposal: The Decorum Committee proposes the continued use of the raise-hand emoji for commenting or questions used during GA and committee meetings. The raise-hand emoji creates a cue, but there are times the technology drops and in these cases we must be patient. In addition, we will cease using the open-mouth emoji for immediate recognition. If a comment will answer a question and save precious time, please say "May I." In all cases the moderator retains the right to accept or reject the request.
