Outreach/Freedom Guides, by Kimberly W

- Summary: Report placed in the chat. Several meetings regarding orientation, decorums, IT with a lot of typing/format work. Donations for AVR: QR code in report to donate directly to her. The banking committee discussed making donations directly to AVR from the Michigan Assembly, as noted above. Ombudsman/Oversight, by Debra GW

- Summary: Voting on proposal later in the meeting regarding decorum for Telegram Supergroup channels. Shared a perspective from South Africa regarding codes of conduct and respectful

interaction. A video entitled “Mastering the 3 most important motions – Robert’s Rules made simple” was presented. Working on these ideas and others for our own decorum guidelines on Thurs at 6pm.

#### Vetting, by Rick W

- Summary: Need an actual background check to open up a Clear Checks account; that may be in the near future with the election of Marshal At Arms Pro-Tem later in the meeting. Reviewed roles section of the Vetting documents and made some adjustments. Continental Marshals are providing training videos for the Vetting Committee so they can learn what to do.

#### Information Technology & Communications, by Jan B

- Summary: IT and Outreach have a proposal for a Michigan Assembly LinkTree. Nicholas K has a proposal for a Discussion Forum on Telegram. Discussed IT budget including annual recurring expenses and possible computer needs and storage for various committees. Need more written content for the website; list is on TG. Need copies of meeting minutes and agendas that still need to be put on the website (Linda S will assist with this).

#### Litigation, by Troy B

- Summary: An apology was made to the Working Group for presenting litigation information to the wrong forum last week, and presented it to the GA this evening (can listen to recording for details at 30:50min). First official Litigation Committee meeting was held on Sunday August 25<sup>th</sup> at 1pm. Discussion focused on the Jural Assembly pillar. Troy requested everyone to refer to AVR’s article #3254. Litigation is a subcommittee of the Jural Assembly function. Every state should have its own Litigation Committee to help men and women who are being attacked and seeking relief.
  - ➔ **MOVE** to establish the Jural Assembly Committee/Standing Pillar was made by Troy B, seconded by Aaron SC. Discussion followed. Please listen to the recording for details of that discussion (starts at 34:50)
  - ➔ **AMENDMENT to the MOVE** to review the Jural Assembly officers and roles in the Working Group before establishing an actual Jural Assembly Committee made by Debra GW, seconded by Troy B.
    - VERBAL VOTE**: “*Shall we amend the move from the establishment of a Jural Assembly Committee to reviewing the Jural Assembly Committee officers and roles in the Working Group?*”
      - **YES** or **NO** – **PASSED** – move is amended
    - ➔ **MOVE**: “*Shall the Working Group review the Jural Assembly Officers and Roles for the eventual establishment of our Jural Assembly pillar?* (vote in chat starts at 7:53pm)
      - **YES = 16**; **NO = 0**; **Abstain = 0**                      **PASSED**
    - ➔ **People need to volunteer to get the Jural Assembly Committee established.**

#### The Working Group, by Rick W

- Summary: Amended proposal for business purposes in TG Supergroups scheduled for a vote tonight. Temporary Outreach Director role has been added to the Michigan roles document to allow for the Outreach leadership to act as a PKTF Liaison while championing outreach efforts. Did not review roles but learned about litigation instead. Its all good, we are all learning!

- 1) Changes in Roles: Nicholas K is stepping away from Proofreading role due to work schedule. Mary K is stepping away from Freedom Guide role due to work schedule. - 2) Continental Marshals: Please contact them directly if interested in becoming one.
- 3) New Credential Cards: Available now via detailed instructions on the LRO log-in page. Please read carefully. Yes, they are requesting autographs done with fine black ink; will be scanned blue on your card.

- 4) Two new committees: Banking Committee on Mondays at 7pm. Litigation Committee on Sundays at 1pm. Both of these committees are for assemblymen only. The PUBLIC Educational Litigation meeting will continue on Fridays at 7pm. ZOOM links are available in the updated links document Amy H emailed this week.
- 5) How to Build An Assembly: Reviewed a visual of a steering wheel showing the 3 pillars (Militia, Jural, and Business) with the GA being the driver of the steering wheel. Reviewed the Jural Assembly with the various roles and committees needing volunteers to build it. - ➔ *“Shall we accept the proposal by the Ombudsman Committee as described in the attachment to meeting agenda? (added to chat at 8:21pm)*
