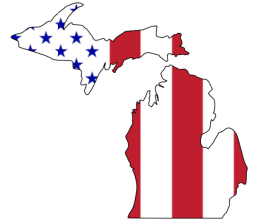

- Proposal regarding censure of committee chairs: (Nicholas K)

  - Details of the original proposal are in the agenda but was not specifically addressed tonight.
  - Presented as a "fool's folly warning". Not calling out anyone specifically. Silence is considered a "NO" so its important for assemblymen to speak up and engage in discussions. Ignorance plus good intentions can lead to more harm to ourselves as an assembly. Nicholas repealed this proposal; just wanted to voice his concern.
- Proposal regarding establishment of Oversight Committee: (Nicholas K)

Details are in the agenda. Please listen to recording for discussion, both before the proposal was made and after (starts at 00:37:15 in recording).

  - Clarification was made that Oversight is for criminal investigations and Ombudsman is for internal conflict or interpersonal relation issues.
  - **MOVE** the creation discussion of the Oversight Committee to the Working Group for further development made by Nicholas K, seconded by Linda J.
  - **Verbal vote: YES or NO – PASSED – discussion continues in the Working Group**
  - Jan B's addition was read after the vote and will be included in the discussions.

- Proposal to change the GA meeting schedule: (Kimberly W)  
Proposal to open discussion regarding changing the GA meeting schedule as outlined on page 3 of the agenda was made by Kimberly W, seconded by Linda S. Discussion followed (starts at 00:48:00).

  - As mentioned under the Reports section, the proposal is going back to the Ombudsman Committee to work thru it line-by-line (earlier discussion can be found at 00:17:30 in recording).

- General Assembly members are marked with an asterisk (\*) before their name. Everyone else is a guest. Guests are welcome to observe but shall refrain from speaking

01:22:33 \*Kenny (Kenneth) Fisher/MAA/Allegan: If anyone speaks out of turn or over three (3) minutes, strays off topic or does not follow the meeting protocol, the following will happen:

- 1st Offense – Marshal at Arms will mute your microphone and give a warning.
- 2nd Offense – Marshal at Arms will mute your microphone and disable your video. You will not be acknowledged to speak for the remainder of the meeting.
- 3rd Offense – Marshal at Arms will remove you from the meeting.
- The same protocol applies to the chat function. Keep chat appropriate, on topic and cordial. Inappropriate items include any files or attachments not directly on the agenda and discussed by voice.
- Offenses are counted as three total, whether by voice or chat.
