Designated committees will have approved budgets. An authorized representative of a committee will request funds from the Treasury/Banking Committee. The Treasury/Banking Committee will release funds up to but not to exceed the designated committee's approved budget. For this process to work, the Treasury/Banking Committee needs an approved spending limit. The Treasury/Banking Committee is requesting the General Assembly to approve \$1000 spending limit.

Proposed flow:

- 1) Committees submit budget to Banking Committee
- 2) Banking Committee reviews requests and submits an overall budget to the GA
 - a) Funds will be allocated to committees in order of their importance to the overall GA
 - b) Monies will be approved as funds are available
 - c) A quarter of annual budgets allocated at this time due to the limited funds available.
