#### The Working Group, by Rick W

- Summary: Rick W offered his opinion about the purpose of the Working Group and what he's trying to do as the committee chair. Purpose of the roles document is to encourage members to sign up for a role, learn about it and possibly lead that effort when those committees are eventually organized. Last week's discussion centered around getting New Member Orientation educational materials established quickly so we can handle an influx of new assembly members. Formatting and content will be shared with other assemblies so there is consistent information gathered. ### Coordinator Updates (recording 00:26:45)

- **Anna is writing a lot of articles** – Lots of International Notices. Amy H encourages ASNs to stay current with these articles; lots of activity on the Federation level.
- **State Assembly Committee Chairs** – Working our way through the election of the Ombudsman Committee Chair, with Candidate Q/A this evening. Next is the Oversight Committee Chair. Amy has received a guidebook from the California Assembly for Michigan to use as a starting point for structure; emailing that out to GA members. Nominations for the Oversight Committee Chair will be accepted next Tuesday, Oct. 15<sup>th</sup>. A date for Candidate Q/A will be determined after the GA votes on the meeting schedule proposal tonight.
- **Investigation** – A man in the GA has asked MAA Kenneth Fisher to investigate the Working Group, accusing that group of taking unilateral action prompting GA members to fill roles in other assembly pillars. MAA Kenneth Fisher reported there was no evidence to back up that opinion. No positions were filled in other pillars during the Coordinator's absence. The opinion was without merit; the investigation is closed. MAA Kenneth Fisher provided the Assembly Guide for Disruptive Behavior from the California MAA and Continental Marshals. Recommends reading it and using the form and process to report to the Marshal's office.

  - Mark S challenged the GA to collect an additional \$300 to match the \$500 donation. Options for donating are above under the Treasury Report. Designate donations for the PKTF so it's included in the challenge.
