  - *Should The Michigan GA approve or deny the already paid \$500. (\$10. per copy) for distribution of the "Resurgence" booklet, for public education of the fraud?*
  - Dolores Fernandez Rubio shared her experience of handing out the “Resurgence” document at a recent Michigan Homesteaders event, neutrally representing themselves as “Friends of Michigan History”, and not representing the Michigan Assembly officially. This booklet was developed by the International Outreach Think Tank and focuses on American history. 15 out of 50 copies printed were distributed; 35 remain. \$75.00 has been donated to this effort so far. Good discussion followed with Kimberly Mayer Watling providing background to the development of the document from an outreach perspective.
  - The GA will vote on this proposal June 3, 2025, requesting reimbursement for the \$500 already spent.
  - Further discussions can continue in the Education Committee for tailoring the booklet for Michigan.
