Reports

Treasury, by Mark Steinke

- Balance in accounts: **\$4,262.56**
- Summary: Treasury report shared (attached). Anna mentioned a need for a designated bank contact via article #5378; the Coordinator will give an update in her report. The GA has not approved all of the requested committee budgets for 2025, including the annual payments for the ZOOM account (\$500), PO box (\$210), and the International Ombudsman Training Course. Total donations for the training course are currently at \$915.97, leaving a balance of \$1580. The Treasurer plans to pay the ZOOM and PO box bills this week if there are no objections from the GA. The question was raised to the GA and there were no objections.
