Treasury, by Charlie Raffoul

- Summary: Work on and discuss things not taken up by other committees. Currently working on GA guidelines (~50% complete) and refining the GA proposal process workflow. Clarified there is only ONE “committee of the whole”, the GA, when working on a specific issue. Clarified the roles of the Ombudsman and Sergeant At Arms (currently Marshal At Arms) are elected roles, they chair committees, and have deputies to help with duties, but they are not called “Chairs”. PKTF Liaison, by Kimberly Watling

- Summary: Shared the PKTF official website <https://pktfnews.org/>. Gave an update on the American Resurgence Project that launched today, July 1<sup>st</sup>, 2025. A reference guide was shared and will be available along with other support information from the PKTF to assist assemblies with education for the public and State of State organizations. These reference guides are posted on the PKTF Liaison Telegram supergroup channel. Shared the PKTF blogspot website <https://seeksearchfindtruth.blogspot.com/>. Examples: speaking off-topic, treating another man or woman disrespectfully, or going over a time limit while speaking. Any man or woman can use the term “call to order” to bring the meeting back into order.

## In Process Items

- **Use of Closed Captioning** (Amy Hunt, interim Records Committee Chair)
  - Proposal Designation: **GA-20250003** (Recording 01:06:40)
  - *Shall The Michigan Assembly approve the use of Closed Captioning transcriptions during any GA Business Meeting?*
  - This updated proposal was brought back by the Records Committee for consideration. The AI portion was removed. This proposal is only asking approval to turn on the Closed Captioning to assist men and women who are having difficulty hearing or understanding what is being said during the GA business meeting. A transcript does get saved to the Zoom account when Closed Captioning is used but it does not show any names of who said what, just words and time it was said. A vote was taken by a show of hands whether the GA would be ready to vote on this at the next GA business meeting on July 15<sup>th</sup>. Fifteen (15) hands were raised in approval of voting at the next meeting, verified by the MAA. (Recording 01:14:00)

## New Items

- **The Michigan Assembly Declaration of Peace on Michigan State** (Kimberly Mayer Watling, living woman)
  - Proposal Designation: **GA-20250005** (Recording 01:15:20)
  - *Shall The Michigan Assembly “Declare Peace” on Michigan State? and, If we “Declare Peace” on Michigan State; Shall The Michigan Assembly challenge all other State; Global and People’s Assembly’s to “Declare Peace” also?*
  - Kimberly read the proposal to the GA. Discussion followed. There are two questions being asked so this probably needs to be considered as two proposals. Several suggestions were made including adding more “meat” to the proposal with action items; providing a written document clearly declaring our intentions; and consider the timing. Approaching local post offices with information about flying the Civil Peace Flag in place of the Title IV flag was suggested. Reminder that we have the authority now to do what we are doing so stand strong. Please see the recording for the details.
  - **Note:** Every nation has a Peace flag and a War flag. The Michigan Assembly is flying the Civil Peace Flag.
  - The Outreach Committee will take up this proposal for further discussion; meetings are Thursdays at NOON. If you are unable to attend the committee meeting, please contact Kimberly directly with your suggestions.
  - This proposal will remain on the GA business meeting agenda for the next meeting on July 15<sup>th</sup> as an **In Process Item**, until it is either voted on or withdrawn.
