Treasury, by Mark Steinke

- Balance in accounts: **\$3,461.19**
- Summary: Treasury report shared (attached). Brief update on Anna's indemnity bond initiative. More info at [Private Indemnity Bond - The American States Assembly](#). The Treasury Committee agreed to share the unapproved Michigan Assembly *Treasury and Banking Guidelines* with the International Treasury Think Tank. Two proposals for the GA will be written up soon: 1) approve the *Treasury and Banking Guidelines* and 2) approve the sharing of documents and guidelines in general to other assemblies. Still waiting on the check from Teri Sahm for \$2014.23 to the Michigan Assembly for the 2023 and 2024 LRO distributions; Amy Hunt will ask about it at the next Sunday coordinator call if it doesn't arrive this next week. Explained what the Coral AI transcription service is (not software); Richard tried the "free trial" with his older computer system. It worked! He's purchased it himself to use for transcribing podcasts and webinars, and wants to explore whether his account is shareable. He plans to put together a proposal for the GA to see if the GA wants to own this sort of service; \$144.00/year.
