A Special Session of the GA is being called for next Tuesday August 12<sup>th</sup> at 7pm to discuss an email from the PKTF; Amy will email a reminder to the GA. During the Continental Bridge Call last week, a group of ASNs are heading up the radio program, going state to state, setting up dispatch repeaters, starting with Michigan. Similar to what the police have right now, to assist men and women with emergencies. American Peacekeeping Communications (APC) along with the PKTF. (Recording 00:49:30)

- Summary: The new proposal form is done, on the GA member website, and available for use. Continue to work on guidelines (about 50% done). Hoping this work continues to climb as we focus back to guidelines. Meet Wednesdays at 4pm. (Recording 00:55:40)

#### PKTF Liaison, by Kimberly Watling

- Summary: The PKTF Liaison training starts back up on August 9<sup>th</sup>, 2025 at 7:30pm for 12 weeks (six sessions deep). All are welcome to join! Peacekeeping Task Force Liaisons (total of 3) on Michigan are still needed so contact Kimberly if interested. During the training break, Kimberly presented a *right to travel* process called “Happy Trails” at last week’s Marshal’s bridge call. Had a meeting with Ellen Miller, Executive at the International Ombuds Association for relationship building; looking for scholarship to assist with cost for ombudsman training for common law. Radio dispatchers needed for Michigan; this is a vetted position; contact Kimberly, Kenny, or PKTF directly. Mentioned a PKTF page/link on both the public and GA member websites, under Education. Gave update on the **Resurgence** project. Mentioned two documents available on state websites describing, in their own language, who we are as State Nationals; these may be useful in helping better define who we really are as we develop relationships with our subcontractors. Links to those documents, along with a couple videos she mentioned, are attached on page 5 of these minutes.
- Next Tuesday, August 12<sup>th</sup> at 7pm – Special Session to introduce the **Peaceful Operation Ten-fold Shield**. Focus is the development of the Assembly’s Militia Pillar, establish the lawful state board of defense concepts and readiness of the public safety committees. (Recording 00:56:47)
