This has been an issue for over a year so need to continue working this out with Teri Sahm.
- Calling out the bad behavior of a GA member: Rene McGuigan engaged in a conversation with Alex Rouscoue in the early hours of September 14<sup>th</sup>, 2025, which resulted in the removal of Rene from the Michigan Assembly PUBLIC channel. The Coordinator shared a PDF of the conversation in the chat for reference. The Coordinator has requested a "new item" for the October 7<sup>th</sup> GA business meeting titled "*Dealing with Rene McGuigan's Disruptive Behavior*", where the GA will have the opportunity to ask questions and share their thoughts regarding the pattern of disruptive behavior over the last several months, with the Telegram conversation being the latest.
