Treasury, by Mark Steinke

- Events Committee: We need to develop this! If you are a party planner or organizer at heart, please consider this role. Helps with organization and venue portion of Elections. Contact Amy Hunt if interested.

But a Jural Assembly Organizer would be helpful to coordinate the Jural Pillar; a Militia Assembly Organizer would be helpful to coordinate the Militia Pillar, and an International Business Assembly Organizer would be helpful to coordinate the IBA Pillar. - **The Michigan Assembly Affirmation to Uphold Peace and Out-law War on Michigan Nation State** (Kimberly Watling - Outreach Committee)
 - Proposal Designation: **GA-20250005** (Recording 01:01:25)
 - *Shall The Michigan Assembly Affirm to Uphold Peace and Out-Law War on Michigan Nation State?*

- The version shared in the agenda was not ready to present to the GA for consideration. The committee is still discussing this proposal. Feel free to review it from the member's website and share any comments with the committee on Thursdays at noon, or email Kimberly.
- **Treasury and Banking Guidelines** (Mark Steinke, Treasurer)
 - Proposal Designation: **GA-20250008** (Recording 01:07:30)
 - *Shall The Michigan General Assembly approve "2b Treasury and Banking Guidelines"?*
 - The Treasury Committee discussed the question from October 7th regarding the maximum balance in accounts. The committee decided to remove the section about maximum balances in accounts from the guidelines. With Prosperity Accounts hopefully coming online soon, the concern for what to do with large amounts of FRNs is minimal. Also, the GA may want to consider purchasing an LRO server or other assets rather than invest in gold or silver or remove the cash.
 - (time stamp 01:11:00) The Treasurer asked to call a vote tonight for the GA to approve the guidelines as currently written. By a show of hands, GA members agreed to vote on this tonight (12=YES, 7 not raised)
 - Proposal language was placed in the chat at ~01:14:20 and members voted via chat.

- **Disclaimer - Short Form** (Nigel Turtle, Jural Assembly Working Group)

 - *Shall the Michigan General Assembly adopt the short form Disclaimer attached in this proposal for reading as part of the meeting protocol in GA Public Meetings and GA Business Meetings?*
 - Nigel Turtle read the short form disclaimer.
 - This short form disclaimer would be integrated into the meeting protocol for the GA business meeting, and may also be appropriate to be read at other meetings. - **Disclaimer - Long Form** (Nigel Turtle, Jural Assembly Working Group)
 - Proposal Designation: **JA-20250010** (Recording 01:24:35)
 - *Shall the Michigan General Assembly adopt the long form Disclaimer attached in this proposal for use in public meetings organized by the Litigation Committee?*
 - The Jural Assembly Working Group would like this long form disclaimer to be included with the decorum guidelines, which is currently in the meeting minutes for the Peacekeepers on Michigan (Militia Working Group). Discussions will continue on Tuesdays at 4pm.
 - The latest iteration of the long form disclaimer is on the GA members website under Announcements.
 - This proposal will remain on the agenda until a committee returns it to the GA.
- **Zoom Guidelines** (Jan Buzard, IT/Communications and Education Committees)
 - Proposal Designation: **GA-20250011** (Recording 01:27:00)
 - *Should the GA adopt the new Zoom Guidelines?*
 - The reason for these guidelines is so everyone knows what we are supposed to do when using Zoom, opening meetings and using the chat.
 - Rick Worden mentioned that this proposal was discussed during last week's GA Working Group meeting and there weren't any issues with other guidelines.

- **Outreach Shipping Costs** (Kimberly Watling - Outreach Committee)
 - Proposal Designation: **GA-20250012** (Recording 01:31:10)
 - *Shall we approve a \$100 per year budget to be used for shipping costs related to Outreach?*
 - Kimberly Watling read the proposal to the GA.
 - There was a question about urgency as the proposal states “routine” but also asks for an immediate vote if possible. The current situation was explained where Amy Hunt has gone to Treasury, asking for permission to pay for shipping/handling with each order of promo cards. This is because there was no budget submitted for this application earlier this year as the store had not been set up yet. The cost for shipping is already included in the promo card price and this isn’t intended to be a money maker.
 - There was a question about how this proposal serves the people on Michigan and another question asking about the store in general.
 - The proposal will return to the Outreach Committee for further clarification and remain on the agenda.
