Bundling recurring expenses across all committees where appropriate was suggested. (recording 00:08:10)

Report from the Banking Committee on data from March 4th GA business meeting

The spreadsheet of data compiled from the budget presentations on March 4th was shared at time stamp 00:16:25. The Banking Committee reviewed it earlier in the day to prioritize immediate needs and 60 days out. That shorter version of the spreadsheet is attached to these minutes.

Prioritizing GA budget needs

Hard drives and storage issues were discussed for all committees. (time stamp 00:26:40)
Discussion about itemized supplies and equipment highlighted (time stamp 00:33:45)

What is the will of the GA? Should Committee Chairs have a hard drive that can be passed on to the next Committee Chair? Are we going to continue to supply toner for the Michigan Assembly printer? Strategic decisions need to be made as we work through the process. Focus on committees that are doing the work to help the assembly grow. (time stamp 00:37:05)

It was determined that 2TB hard drives should be sufficient for most Committee Chairs; 6-10TB for the archivist.

Donations to the Assembly: *anytime someone wants to donate something and specifies what it is for, the Assembly honors that.*

- First: Fast track immediate needs: printer toner, paper, stamps, seals, domains and hard drives

One of the top priorities of the Treasury is to make sure the GA operates effectively. So when we look at the budgets from the committees we should consider what they need to keep operating effectively.

I think we can all agree that to get the pillars established, we need growth. To grow efficiently I feel we need to have a strategic plan for that growth. Set some goals. Achieve these goals. Have a party! And move forward.

We are trying to eat an elephant, one bite at a time. But it seems we are all taking bites from different parts of the elephant. I feel strongly that we need a strategic plan or a path for growth. This is especially important going forward after we have satisfied our short-term committee needs. What should the priority of our spending be?

To function effectively as the Treasurer I need to know the will of the GA. Its also important to have a plan to help establish a funding process.

Earlier today, the Banking Committee determined that the Treasury should retain a minimum balance of \$500.00 on deposit between the accounts. We currently have approximately \$4800.00. After subtracting the minimum balance and the \$500 pay-it-forward, the remaining balance of \$3800.00 is available towards budget needs.

After the GA has prioritized the short-term committee budget needs, we can discuss the strategy for using the remaining funds for growth.

But 1st before we get into prioritizing budget needs. We will open it up to ask the committee chairs about their budgets.
