### Providing a free option for Recording and Publishing of Status Correction paperwork

#### Proposal Information

---

**Proposal Question:** Shall we offer free Recording and Publishing of status correction paperwork if someone autographs an Affirmation of Intent?

---

#### Describe how this proposal serves and/or protects the people on Michigan:

This proposal hits the root of how we serve and protect the people. Freedom should not cost money or engage commerce! Nobody should have to pay to come home. We would still have the three payment options (\$10, \$5, \$3 for the 1779 package as an example), but we would add two additional options:

- 1) Enter your own amount (think BIG donations!)
- 2) Free!

For the protection of The Michigan Assembly, we would require anyone who chooses the free option to complete an Affirmation of Intent. This will prevent any claims of coercion while at the same time not requiring any unnecessary fees.

These new options would be available for all parts of status correction: 1779 Package, 928 Package, Letters Package. These options would not apply to Baby Deeds or Marriage documents because any wo/man can upload these documents themselves to the LRO for free already.
