The Michigan Assembly – General Disclaimer (LONG VERSION)

In the process of constructing the Jural Assembly on Michigan with courts for living men and women, people sometimes share strategies through various sponsored channels.

Specifically, The Michigan Assembly Litigation Committee offers a forum for men and women to seek assistance for dealing with personal issues they are experiencing within the incorporated legal systems. This support is provided by various people who might, or might not, be American State Nationals on Michigan or other states. Recommendations for or links to certain types of services are often provided in such forums and are considered part of the knowledge sharing goal of these meetings. However, active solicitation of business is discouraged by those hosting such meetings for the Michigan Assembly and the meeting host will have broad discretion to apply such measures as the Michigan Assembly has approved for its own members.

The Michigan Assembly:

- Does not give any kind of endorsement for the strategies and support shared, except for those promoted and approved by Anna von Reitz.
- Does not accept liability for advice and assistance.
- Does not accept or pass along donations in exchange for advice.
- Does not promote or endorse services offered by its members.
- Does not get involved with any private agreements.
