General Assembly Working Group (GAWG)

- Summary: Continue to work on guidelines. Figuring out how to run the various aspects of a state assembly is the core mission of the “assembling phase”. We must learn what to do and write it down so everyone knows how to do the work. We write guidelines and not standard operating procedures. *From Anna: “We are simple and not creating a bureaucracy like the system we left”.* We still need to write things down so we have a basis for what we do and new people can easily learn what we do. Jural Assembly Working Group (JAWG)

- Summary: Two accomplishments:
1) **Jury Pool Affirmation** TEMPLATES (both Word and LibreOffice) are available on the members-only website along with a document generator for the affirmation as a third option. Instructions will be included. At the next Jury Pool Committee meeting, those on the committee will be doing their affirmations.
2) We have reached out to Lisa Schaffer on Ohio to come to our next JAWG meeting on Monday June 1st to discuss Ohio’s court documents. If we decide to we can adopt them rather than reinvent the wheel. *All interested assembly members please attend!*

Militia Assembly Working Group (MAWG)

- Summary: Good meeting today! The PKTF Liaison visited and reviewed radios for the group. We are working on committees, volunteers and guidelines. There is a survey on the members-only website for assemblymen to vote on the Militia patch logo. Discussed a public survey so the people on Michigan can vote! Next meeting: Tuesday May 26th at 4pm. International Business Assembly Working Group (IBAWG)

- Summary: We met on May 6th and May 13th. We are finalizing the maturity assessment presentation to show to the GA on June 2nd. We are also working on guidelines. Reminder that once the IBA is seated each member must be either an ASC or ASC-eligible. This involves status correction (become an American State National) and those who become American State Citizens (ASC) do not have dual citizenship, for example obligations to other governments and jurisdictions. - Personal Demand Letters: Anna offered a template and instructions for ASNs to assert their personal claims to non-citizen status. The details are in articles #5833 and #5834. This is not about status correction but it does notify the relatively new Trump Administration of our own personal status. It is not directly assembly business but it does protect the assembly by protecting the people who are part of the assembly. For each assembly member to consider.

 - An announcement is posted on the member-only website explaining where to find the second revision and the updated proposal so people can read both as a refresher.
 - We will be voting on this at the next GA business meeting on June 2nd, 2026.
- **Elections for Court Roles** (Nigel Turtle, JA Working Group)

The document he was working on for the IBA can be forwarded to Nigel and perhaps he can bring it to the IBA as a Jural Assembly contribution. Anna wants to see changes in the assemblies so requesting Lisa Schaffer and Paul Pappas to do the training to get people up to speed as soon as possible.
