- **Disclaimer - Long Form** (Nigel Turtle, Jural Assembly Working Group)
 - Proposal Designation: **JA-20250010** (Recording 00:31:30)
 - *Shall the Michigan General Assembly adopt the long form Disclaimer attached in this proposal for use in public meetings organized by the Litigation Committee?*
 - The second revision and the updated proposal have been available for members to read on the members website. The proposal and revised disclaimer were read through again tonight.
 - Dolores Rubio Fernandez requested voting on this tonight; Debra-Ann Garcia-Wagner offered secondment.
 - A brief discussion followed with clarification of some of the content.
 - [Time stamp 00:52:45] Linda Steinke (standing in for Bob (troy) Brown interim MAA) directed the Roll Call vote. Jan Buzard assisted with the vote tally "LIVE and on the screen". The GA was able to watch the vote, helped count, and received the results via a PDF in the chat.
 - **RESULTS** from interim **MAA**: **YES = 16** **NO = 0** **PASSED** [1 Present, 40 Absent]
- **Elections for Court Roles** (Nigel Turtle, JA Working Group)
 - Vetting continues for the Coroner, Justice and Bondsman. Still looking for volunteers for other court roles needing to be filled, especially Court Clerk. Several roles need filled. Please email Nigel Turtle if interested. (Recording 01:00:25)

Proposal Information

Proposal Question: Shall the Michigan General Assembly adopt the long form Disclaimer attached in this proposal for use in public meetings organized by the Litigation Committee.

Origination Details:

The idea was referred to the Jural Assembly Working Group by the GA coordinator as a result of certain anonymous concerns raised about conflicts of interest or perceptions of conflicts of interests generally and in particular when individual members involved in litigation, recording, outreach and other public facing work of the Assembly are giving assistance to existing or prospective ASNs in a private capacity.

Describe how this proposal serves and/or protects the people on Michigan:

The Disclaimer is designed to protect both the Michigan Assembly and Members of the General Assembly individually against harm or recrimination when such individuals have a direct or indirect interest in any business with ASNs, Assembly Members or the Assembly itself, especially when those involved in the work of the Assembly are giving assistance to existing or prospective ASNs in a private capacity. The Disclaimer also serves the people on Michigan more generally by reminding them of their responsibility when making private agreements.

This Long Form of the Disclaimer covers the same basic concerns as the Short Form Disclaimer but provides some additional background and details.

For example, it expressly describes the situation where Assembly Members from other states are participating in any Michigan Assembly forum or offering private business services to people on Michigan, which is also covered by the short form but only in a general way.

From the October 21, 2025 GA business meeting minutes:

- The Jural Assembly Working Group would like this long form disclaimer to be included with the decorum guidelines, which is currently in the meeting minutes for the Peacekeepers on Michigan (Militia Working Group). Discussions will continue on Tuesdays at 4pm.
- The latest iteration of the long form disclaimer is on the GA members website under Announcements.
- This proposal will remain on the agenda until a committee returns it to the GA.

The latest revision titled “Long-Form-Disclaimer-Rev1.pdf” is now attached to the proposal.

(updated by Linda Steinke 11-12-2025)

– The “Long Form Disclaimer Rev 1” was updated and presented to the GA on May 5, 2026. Nigel will make an announcement on the member-only website and the updated “Long-Form-Disclaimer-Rev2-JAWGMOM-0069-Item-48-1.pdf” will be attached. It is also attached with this proposal.

– Because the Long Form Disclaimer refers to the Members Etiquette (formerly Decorum included in the first revision) it could only be re-presented once the GA had approved the Member Etiquette. (updated by JAWG 5-11-2026)

Proposal Question: Shall The Michigan Assembly use an online vote tally system when voting on proposals and other elections during GA business meetings?

Origination Details:

The Michigan Assembly has gone through several methods of voting during GA business meetings. First we started voting in the chat; now we are doing Role Call votes for proposals. Jan Buzard has recommended a program (Foxit PDF Reader) where the vote tally can be watched during the meeting. The software needed is free. This was originally brought up as an idea in December 2025.

Describe how this proposal serves and/or protects the people on Michigan:

It makes voting more transparent and creates an instant record that everyone can have during the meeting via the chat, including the Minute Taker who needs it for the final minutes. People can count the vote immediately. The MAA will oversee the process but does not need to run voting per the Continental Marshals. (see Tennessee Town Hall meeting 4-10-26). The MAA will also not need to send the final vote count to the Minute Taker which is just added work for him.
