As The Michigan Assembly develops its processes and guideline documentation, there is a need for the people to oversee and assent to what is being developed prior to ultimate full approval. Developing guidelines is an iterative process, requiring formulation of ideas, composition of clear and descriptive texts, practicing what is created to demonstrate its practicality and effectiveness, and making adjustments where necessary. Granting authority to committees and working groups to do the writing and research is essential for getting the work done, but the people must remain in ultimate control of what is produced.
